### CATEGORIES

**Oil:** 2 dimensional works utilizing traditional oil paints.

**Acrylic:** 2 dimensional works utilizing traditional acrylic paints.

**Watercolours:** 2 dimensional works utilizing traditional watercolour paints only.

**Photography:** 2 dimensional photographs either colour or black and white, as stipulated by show criteria.

#### Alternate Media includes...

**1:** 2 dimensional paintings or relief works utilizing colour and/or mixed media to include combinations such as oils/acrylics, watercolours, pen and ink, print and impasto, gouache, enamels, encaustic, lacquers, inks, dyes, pastels and textiles.

**2:** 2 dimensional works, such as pencil, pen & ink, graphite, pastels etc.

**3:** 2 dimensional original prints utilizing modern or traditional techniques such as mono, serigraphy, engraving, etching, block etc. excluding copy and photo-mechanical reproduction.

**4:** Sculpture: 3 dimensional works, including reliefs, in materials such as stone, wood, ceramic, marble and others.

### RULES

1. For a non-refundable fee of \$25.00, each artist will be allotted one 4'W x 6'H display space with signage indicating the artist's name. In addition, 9 spaces are available on walls/easels for oversize works (36"W – 42"W) to be selected by draw from applications.

2. This is a juried show. A qualified juror will award a 1<sup>st</sup> place in each of **5 categories** (Oil, Acrylic, Watercolour, Photography, Alternate Media) and Honourable Mention ribbons as he/she sees fit. The juror will not be used to eliminate entrants.

3. Paintings must be framed to professional standards and securely **WIRED** for hanging. (NO saw toothed hangers please) NOTE: Artwork on gallery-wrapped canvas (min. 1.5" in depth) may be submitted without frames but must have painted edges with no staples showing.

4. All work must be original. Any work deemed to be copies of another artist's work will be removed from the show. Work not adhering to category definitions for visual art will be rejected.

5. All work must be for sale. SOYRA will process all sales and will receive a 20% commission.

6. The artist is responsible for insuring their work in the show.

7. No artwork may be removed from the show until after the closing of the show on Sun. at 5:00 p.m.

8. It is the artist's responsibility to pick up their work. Please bring your copy of the registration form for check out. Please inform the show co-ordinator if someone else will be collecting your artwork.

9. SOYRA is not responsible for any work left 1 hour after the show.
